Whether it be lifetime care in our beautiful feline retirement home, a new home through our strict adoption program, or placement in a loving foster home through our unique "Senior Citizens and Senior Kittizens" foster program, we always put the best interest of each of our feline residents above all else, just as you would with your own beloved cat.

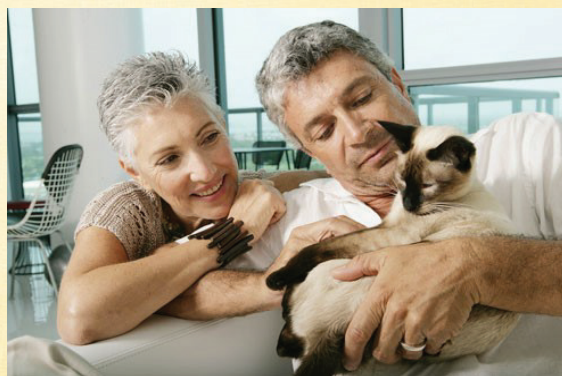

### **WHO WILL BE THERE FOR YOUR CAT AFTER YOU ARE GONE?**



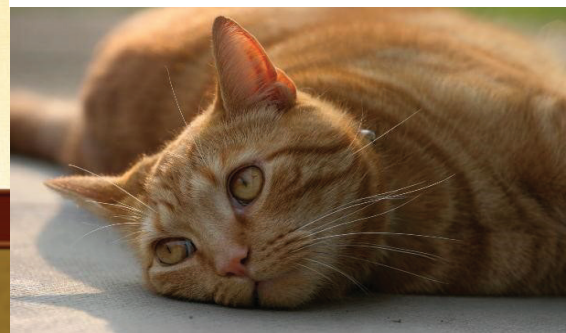
